They would have to manually ensure all contracts met state and local government statutes, policies and procedures, a very labor-intensive process that was utilized for everything from office supply to construction project solicitations. Specifically, they wanted to find a procurement solution that

would reduce acquisition expenses and procurement cycle times while increasing operational efficiency and transparency, especially for larger dollar construction contracts.
