

## NIGP Code Sublicense Subscription Agreement

NIGP – The Institute for Public Procurement (“NIGP”) and Periscope Holdings, Inc. (“Periscope” or “Licensor”) provide the subscription-based use of the NIGP Commodity/Services Code (“Code”) only on the following terms and conditions. Carefully read these terms and conditions.

1. **COPYRIGHT:** The NIGP Commodity/Services Code (Code) is the product of NIGP – The Institute for Public Procurement, licensed to Periscope Holdings, Inc., is protected under the copyright laws of the United States. You may not copy, publish, or transfer the Code, or any copy or merged copy of the Code unless expressly authorized to do so by a subsequent written document signed by an authorized officer of Periscope. Any use of the Code or reference to the Code, including but not limited to on the Internet, must expressly indicate that it is copyrighted by NIGP, and must not be used in any manner by clients and associates of the Sublicensee, other than as stated in this License, including using less than the full code.

The NIGP Commodity/Services Code Crosswalks (MCC, NAICS, and UNSPSC) are copyrighted by Periscope Holdings, Inc. and are protected under the copyright laws of the United States. You may not copy, publish, or transfer the Crosswalks, or any copy or merged copy of the Crosswalks unless expressly authorized to do so by a subsequent written document signed by an authorized officer of Periscope. Any use of the Crosswalks or reference to the Crosswalks, including but not limited to on the Internet, must expressly indicate that it is copyrighted by Periscope Holdings, Inc., and must not be used in any manner by clients and associates of the Sublicensee, other than as stated in this License, including using less than the full Crosswalk.

2. **SUBSCRIPTION:** The Code is for use on a single network for the conducting of subscriber's centralized purchasing operations. This subscription may be extended to include use on networks and/or to other entities within the jurisdiction of the Sublicensee with payment of the appropriate additional fees.
3. **ASSIGNMENT:** The Code and your rights under this Agreement may not be transferred or assigned to another party.
4. **SUBLICENSEE DISCLOSURE STATEMENT:** Unless Sublicensee has prior written approval from Periscope for a deviation from the language indicated below, Sublicensee shall use the following wording for all disclosures:

**NIGP Code:** The NIGP Code is the property of NIGP, is licensed to Periscope Holdings, Inc., and is protected under the copyright laws of the United States. Unauthorized duplication or copying is prohibited.

**NIGP Code Crosswalks:** The NIGP Crosswalk is the property of Periscope Holdings, Inc. and is protected under the copyright laws of the United States. Unauthorized duplication or copying is prohibited.

5. **TERM:** This Agreement and the Subscription created thereby are effective for a three-year term and thereafter on an annual basis unless the parties agree to a different renewal option. The Agreement may be terminated at the end of this term by the Sublicensee or Licensor by providing the other party the reason for the termination in writing, preferably by using Periscope's NIGP Code Cancellation Form. The cancellation request must be sent to the other party prior to the renewal date of the Subscription. Failure to renew the subscription as the result of non-payment of the subscription fee when due will be just cause for early termination of this Agreement. Termination of the Code means you must destroy the Code and all copies, modifications, and portions merged into other programs or copies.
6. **PRICING:** Sublicensee pricing is per the pricing stated on website/order form, on the date of license order.
7. **LIMITED WARRANTY:** NIGP and Periscope's sole warranty is that the Code will be free from defects in materials and workmanship under normal use. In selecting this Code, you assume full responsibility:
- that it will meet your needs for installation and use,
  - that it is compatible with the software and hardware on which it will be used, and
  - for verifying the results obtained from such use.

NIGP and Periscope expressly exclude any warranty that the Code will meet your needs, that the Code will operate error-free or uninterrupted on any particular hardware, or that it will meet any need not expressly described.

**EXCEPT AS STATED ABOVE, NEITHER NIGP NOR PERISCOPE MAKES ANY OTHER WARRANTY REGARDING THE CODE, INCLUDING, WITHOUT LIMITATION, EXPRESS OR IMPLIED WARRANTIES. NIGP AND PERISCOPE EXPRESSLY DISCLAIM THE WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE OR MERCHANTABILITY, AND ANY OTHER WARRANTY, EXPRESS OR IMPLIED.**

**THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS, AND YOU MAY HAVE OTHER LEGAL RIGHTS THAT VARY FROM STATE TO STATE OR BY JURISDICTION.**

8. **LIMITATIONS OF REMEDIES:** Your remedy and the entire liability NIGP and Periscope shall be exclusively as set forth above. Neither NIGP nor Periscope will be liable to you for damages whether under theory of warranty, tort, including NIGP's, Periscope or another party's negligence, product liability or otherwise, including any lost profits, lost savings, or other incidental or consequential damages arising from the use of your inability to use the Code or the breach of any expressed or implied warranty, including negligence, even if NIGP and Periscope or its agent have been advised of the possibility of such damages. In no event shall NIGP and Periscope liability for damages exceed the greater of \$ 100 or the total annual amount paid for the Subscription granted hereunder. Some states prohibit the above limitations, so they may not apply to you.

9. **FURTHER USE OR ASSIGNMENT:** Any attempt to copy the Code as described above or to assign or transfer this Subscription or the Code covered hereunder except as provided in this Agreement, shall void the Agreement.
